Friendship with Jesus

Friendship with God is a key – if not the central, fundamental teaching of Kairos Prison Ministry.

It's the beginning lesson in the construction of the three-legged stool analogy during a four-day weekend. This lesson teaches the inmates that God wants to be in relationship with us. It's a good beginning teaching but I have a question for you.

Are you living in friendship with Jesus?

The reason for asking the question stems from my observation that many Christians treat friendship with Jesus/God in what I consider a very casual manner. It's very similar to this scene.

You walk into church one Sunday morning and you start greeting your friends. Hi Joe, how did the week go? Hi Sue, that sure is a great dress you're wearing today. Hi Mark, how's your son doing in football this year? Hi God, how are you doing?

Casual. No big deal. It's something taken for granted since we are saved, right?

How does God see friendship with him? Jesus explains what it means to be his friend in John 15:9-17.

Jesus and the disciples have left the upper room and are on their way to the Garden of Gethsemane. Jesus explains that he loves them just as the Father has loved him and encourages them to remain in his love by obeying his commands. In 1 John 5:3, we are reminded that love for God is defined as obeying his commands. In verse 15:14, Jesus declares that you are his friend when you do what he commands.

This obedience is not burdensome. Jesus said, "My yoke is easy and my burden is light" (Mt 11:32). It allows us to find joy in life by our willingness to allow our lives to be directed by the express will of God. A disciple's life is not an imitation of Christ but the result of Christ in our life. Our joy is his joy in us. It is not the result of pleasant circumstances, but of wholehearted obedience.

We do not earn Jesus' friendship by obedience. Our lives should provide evidence that such a friendship does in fact exist.

So I ask the question again.

Are you living in friendship with Jesus?

RIFLE 2-DAY

The Rifle team held a two-day retreat on Jan. 9 & 10, 2016. We used the "Wild at Heart" small group video series by John Eldredge. The video series is based on Eldredge's book by the same name. It consists of eight sessions, approximately 30 minutes each, and follows five guys through a series of adventures in rafting, fishing, shooting, repelling, and riding horses. Amid the adventures, the men discuss topics such as the heart of a man, have I got what it takes, wounds, healing the heart, a battle to fight, and an adventure to live.

This video series was very successful in terms of getting the men involved and generating discussion. We showed a video session and then divided the men into small groups for discussion. Attendance was good with over 20 each day. The men were able to relate to the guys Eldredge had assembled in making the video series and the topics were pertinent to the men's lives. The sessions that dealt with relationships, with fathers, and the wounds men receive were particularly beneficial and generated much discussion. We could not complete all eight sessions during the retreat, so the remaining sessions have been used during recent reunions.

THE POWER OF PRAYER

Three years ago my friend, Shawna, was sentenced to eighteen years in the Department of Corrections for a crime she did not commit. She did have a certain level of culpability which had the judicial system worked properly; she could have received a much lower sentence. During her three years of confinement, she has prayed. Prayed for understanding. For peace. For her wonderful husband to come to know and love God as she does. For the court to correct her sentence and lessen it. For her husband, a construction worker, who was without work, losing their home, and selling their possessions to make ends meet. Shawna prayed.

I have known Shawna two of her three years of confinement. Never once have I heard her bemoan her circumstances. She prays. She “gives it to God” daily.

On December 30, 2015, Shawna appeared in court for a sentencing “reconsideration.” Her attorney told her the original sentencing judge personally requested to preside over the reconsideration hearing. Shawna was to appear in court at 9 am.

... At 9 am in Denver Women’s Correctional Facility, a group of women gathered and openly prayed for Shawna’s success. They prayed, asking God to place His hand on the heart and mind of the judge. I was in my room praying, too. I was not praying for Shawna – I was asking God to open the mind and heart of the judge to hear Shawna and to consider her request with a gentle, Christian heart.

The judge told Shawna she had been “haunted” by giving an 18-year sentence and then reduced her sentence to 12 years. At this time, Shawna will apply for release to Community Corrections (a halfway house) in April. Amen? Amen!

Did I mention that Shawna’s husband came to Christ and has committed his life to our loving, saving Lord? He also now has the best job he has ever had and is actively searching for a home for the two of them in Denver.

PRAYER. It’s powerful!

KAIROS PRISON MINISTRY INTERNATIONAL

[Kairos Prison Ministry](#) is a lay-led Christian ministry which conducts a highly structured program designed for use in male and female correctional institutions. The Kairos program starts with a weekend event which allows participants to receive Christ's love through the servitude of Christian Kairos volunteers. During this event participants are given the opportunity to experience a spiritual renewal, accepting God's call to a life of Christian witness and service to one another during their stay in the institution, and beyond. Participants are encouraged to establish small, two-to-five-person "Fourth Day" Prayer and Share groups within the institution. The groups meet regularly to share their lives on a deep spiritual level and to pray for one another, other residents, and staff in the institution.

Kairos is currently in thirty-five states and nine other countries – Canada, United Kingdom, Australia, South Africa, Costa Rica, Dominican Republic, Honduras, Nicaragua, and Peru. The course materials are
